- Photographs must be submitted by close of business, 5.15pm on Friday 21<sup>st</sup> September 2012. Photographs received after this time will not be entered into the competition.
- Only one photograph per entry form. Please complete an entry form for each additional photograph entered.
- Photographs must be submitted in landscape format. Those submitted in portrait will not be entered for the competition.
- Entries must be submitted in high resolution (a minimum of 225dpi, but 300dpi is preferred) digital format (Tiff, jpeg or psd), either by email or on a disc as per address details on the entry form.
- Submitted photographs must be taken by the individual listed on the entry form. Any breaches of this will lead to disqualification from the competition.
- The judging panel's decisions are final. No correspondence will be entered into.
- Entrants must be aged between 11 and 18 years on the closing date of the competition.
- Crowe Morgan will own the copyright of all winning photographs and may use them in the future at their discretion without further permission.
- Crowe Morgan to have the right to use any photograph submitted for future publicity material including their website. In these cases the photographer will be acknowledged. Crowe Morgan will not own the copyright in these instances – copyright remains with the entrant.
- All entry forms must be signed by a parent/guardian
- Crowe Morgan reserves the right to re-categorise the month the supplied photographs reflects to best suit its needs.
